### 1. Welcome and Introductions

Jeannie Bowlen, LNVA CRP project manager, welcomed everyone who joined the virtual steering committee meeting and asked everyone to sign in on a google sign in form. The link was provided in the chat box.

### 2. Aquatic Life Monitoring Results in Segment 0608

Speaker: Randy Rushin, Water Monitoring Solutions, Inc.

First speaker, Randy Rushin, shared his screen with a power point presentation about the Aquatic Life Monitoring results that were found on Beech and Cypress Creeks. His presentations summarized the parameters collected during the monitoring. Monitoring took place from 2019-2021. The main obstacle that took place during the monitoring was planning around rain events that took place. Both streams scored well in spite of the rain events so in spite of not meeting some current water quality standards, that the overall aquatic health of both streams are very good.

Question for Randy: "How long before you can monitor after a rain event?

- "TCEQ says 2 weeks and we try to stay within the time limits."

Question: "Were the flows close to each other at testing spots?"

- "Stream flows are all close, typically 5-10 CFS"

Stakeholder comment: "The systems seem to be in good shape overall, given the amount of rain and still getting high ratings."

### 3. Status Update of the Total Maximum Daily Load and Watershed Planning Projects in the Lower Neches Basin

Speaker: Michael Schramm, Texas Water Resources Institute

Next speaker, Michael Schramm, shared his screen and gave an update on the status of the TMDL and I-plan projects going on in the lower Neches Basin. The current projects include Wolf and Sandy Creek as well as Hillebrandt Bayou and Neches River Tidal. His presentation gave some background on how these projects developed as well as their progress.so far.

Question for Michael: "Is it too late to become part of the stakeholder groups for these projects since the project plans are reaching the comment period phase?"

- "No, anyone can still join the stakeholder groups during this process. It's not too late."

### 4. Texas Aquatic Turtle Surveys: 13 Years of Exploration

Speaker: Mandi Gordon, Environmental Institute of Houston, University of Houston - Clear Lake

Mandi Gordan was next up on the agenda and spoke about the work she and her team are doing looking for chicken turtle and alligator snapping turtle species. Her presentation covered all the resources they are using to locate turtles including a public reporting tool.

She mentioned all the agencies involved with the project. She has also been working with LNVA (Jason Watson and Terry Corbett) on interagency GIS reporting tool. Another type of turtle, the diamond back terrapin turtle, is a favorite turtle of Mandi's. She displayed a large skull of an alligator snapping turtle that was found and given to her.

Question for Mandi: "Can you estimate the weight (of the turtle) based on skull size?"

- "It's hard to estimate the weight, but it would be about 5-6 feet long. Very large."

### 5. Texas Stream Team Volunteer Monitoring Program Training

Speaker: Brielle Patronella, Lower Neches Valley Authority

Brielle Patronella, LNVA and CRP's Quality Assurance Officer, presented an update on the Texas Stream Team and how people can volunteer for citizen stream monitoring.
